Mr. Siddharth Luthra, learned Senior Counsel appearing for the applicant viz., Global Indian International School, states that if any student of the applicant-school has been asked to leave the school, he/she will be allowed to join the school again subject to final hearing of these matters.

List these matters for final hearing in the month of August, 2019.

In the meanwhile, the schools shall not demand any amount more than that which was fixed by the Fee Fixation Committee (FRC). This shall be in supersession of orders passed by this Court earlier.

It is understood that any amounts paid by the students or recovered by the schools shall be subject to the final decision in these matters.

Interlocutory Application being IA No.60170/2019 for impleadment of the applicant viz., Global Indian International School as party respondent, is allowed.
